

# Livingston County Mental Health Board 708 Board Meeting Minutes

May 21, 2015

President Jack Vietti thanked the Mental Health Board staff for a great retirement open house in honor of Carol. Jack called the 708 Board meeting to order.

It was moved by Bob W. and seconded by Steve to approve the April 16<sup>th</sup> and April 30<sup>th</sup>, 708 Board minutes. Motion carried.

. was moved by Laura and seconded by Ed to approve the 708 Board April check listing. Motion carried.

It was moved by Vicki and seconded by Ed to approve the 708 Board April financial statements. Motion carried.

## **Executive Director Report:**

- The legislature is in session right now. Carol reported that there are a number of bills in the House & Senate at this time. One bill in particular that they are watching proposes to consolidate units of government. This could impact townships as well as 708 and 377 boards. They are lobbying very aggressively against this bill.
- There will be no random pulls. The quota has been met for this year. The state figures that any openings will be filled with crisis situations. The waiting list is from anywhere from 15,000-25,000 individuals.
- Carol and her family really enjoyed her retirement party Tuesday night. She thanked everyone for such a wonderful event. There were around 200 guests that attended.
- The 377 Board allocated money to Mosaic to help fund their clients with summer camp. Mosaic registered the clients who want to go to camp and the camp said they are filled up.

## **Old Business:**

- The LCCN is still active and it will need to be voted in by the Livingston County Commission on Children and Youth at the end of the year.

- Carol mentioned the County Board approved the 708/377 Annual Report last week. It was moved by Bob W. and seconded by Ed to approve the FY14 Annual Report. Motion carried.
- Nicole Winterland of the Boys and Girls Club of Prairie Central thought maybe they might need to request the funding for the summer program be used for after school expenses due to the fact that they have a major funding cut because the Governor has cut the TEEN Reach program. Carol reported that Nicole changed her mind and will search for funding to keep the after school program active.
- The 3- year Strategic Plan was presented for approval. Dennis Crowley reminded the board that it is a One-Three Year Strategic Plan which may be reviewed at any time with changes being made as needed. It was moved by Laura and seconded by Vicki to approve the Strategic Plan. Motion carried.
- An amended 708 Budget has been presented to reflect the \$10,000 that was approved to fund the IHR student counseling services in Tri-Point, Flanagan and Woodland schools. The board needs to approve the amended budget. It was moved by Steve and seconded by Mark to approve the 708 Amended Budget dated 5-21-15. Motion carried.

#### **New Business:**

- Jack Vietti and Steve Tock are up for reelection to the 708 Board for a 4-year term. It was moved by Ed and seconded by Mark to approve the reappointment of Jack Vietti and Steve Tock to the 708 Board for a four year term. Motion carried.
- The election of the current slate of officers as presented are. Jack Vietti – President; Ed Legner – Vice-President; Bob Walter – Treasurer, and Laura Leslie – Secretary. It was moved by Mark and seconded by Steve to re-elect the current slate of officers. Motion carried.

Carol reported that the Illinois Center of Excellence for Behavioral Health and Justice has scheduled a mental health training for Thursday, June 18<sup>th</sup> from 9-4pm. to be held at the Law & Justice Center. The judges, States Attorney office, probation, Futures Unlimited, IHR, all local and county police departments. Carol has been to previous presentations and they do an excellent job. The training is free and offers CEUs.

- Due to the Mental health Training being on the same day as the next 708/377 Board meeting on June 18<sup>th</sup> from 9-4pm., Carol would like to suggest the board meeting to be changed to 4:30pm. This was fine with the board members present.

#### **Agency Comments:**

##### **Institute for Human Resources:**

- Joe announced that their Livingston County Snowball Chapter has won the "Chapter of the Year Award" for the state. Joe recognized Tiffany Yoder, Gary Beier and Jack Bristow for their leadership and passion for the program, including Teresa Diemer. Thanks to the 708 Board funding this has been made possible. There will be a presentation next week at IHR.

##### **Futures Unlimited:**

- Karen attended the Institute on Public Policy last week and the new DDD Director, Greg Fenton, was there. Karen said he is a personal guy and talked about DD department at DHS. He would like to change the ROCS system and they are still using Lotus at the state level. The people that run the system can never retire because they are the only ones that know how to run the system. He is also discussed the implementation of the 1115 waiver. No one is talking about the budget at the state level.
- Futures Unlimited had their annual awards reception and Tracy Wyant won the Spirit of Futures Award, Thorton's won the Supporting Business Award, Wendy's won the Supporting

Employer Award and Salvation Army was Supporting Partner. A special acknowledgment for Carol Flessner for her service to the county and a special acknowledgement for Verla Tauber and her late husband were some of the first founders who helped start Futures Unlimited 45 years ago. Verla just celebrated her 100<sup>th</sup> birthday.
